# 3. Approval of Minutes

After a short discussion and hand vote, a motion was made by Zalma Quezada to approve selecting the first design option with recommended revisions. Noah Andrews seconded. The motion passed unanimously.

Ms. Tignac stated that the graphic design must go through the City's approval process, which may affect the final product.

c. Discussion of Youth Summit Participation Parameters

After a brief discussion, Alex Judge made a motion to include opening participation for the 2015 Youth Summit to students in eighth through twelfth grade. Allison Gillies seconded. The motion passed unanimously.

Ms. Tignac stated that she would request approval from the Simi Valley Unified School District to allow eighth grade students to participate in the Youth Summit as school business.

Youth Summit Vice Chair Nick Steinwender explained the responsibilities of group leaders and stated that the committee had assigned group leaders for each topic.
